

**CLAIM FORM**

**THE DEADLINE TO SUBMIT THIS CLAIM FORM IS MAY 26, 2013**

This is the official claim form you must use to make a claim in Gallagher v. Title Company of Jersey, Michael Dowling and William Gillingham (“TCJ”), Docket No. SLM-L-67-12 filed in the Superior Court of New Jersey, Salem County. Please read this form carefully before filling it out.

In order to qualify for relief under the settlement, you must own real estate located in New Jersey and been charged a fee to record a mortgage (Mortgage Recording Fee) and/or a fee to record a deed (Deed Recording Fee), which is typically reflected in line 1201 of your HUD-1 Settlement Statement, by TCJ in a transaction that closed during the period March 13, 2006 to the February 25, 2013.

To be eligible for benefits under the settlement, your settlement statement (commonly known as a HUD-1 Form) must reflect that you paid a Mortgage Recording Fee and/or Deed Recording Fee to TCJ in an amount greater than that permitted under the applicable provisions of the New Jersey Title Rate Manual but only to the extent that TCJ does not have a right to offset for other fees not charged to you but paid by TCJ. This may or may not have occurred in your situation. The responses and information you provide to the questions set out below are designed to see if you qualify for a payment. If you qualify, you will be eligible to receive a refund of up to 100% of the excess charge.
