This is the official claim form you must use to make a claim in the lawsuit captioned as Thomas J. Styczinski v. Westminster Mint, Inc., Bullion International, Inc. d/b/a Highland Mint and International Fulfillment House, Ian Clay, individually, and Michael Kott, individually (collectively referred to herein as “Defendants”), Civil Action No. 14-cv-619 SRN/HB, which was filed in the United States District Court for the District of Minnesota. Please read this form carefully before filling it out.

In order to qualify for relief under the settlement, you must be a resident of the United States who purchased a “Silver Round – American Silver Eagle Design” (“American Eagle Silver Round”) and/or a “Silver Round – Timber Wolf/Maple Leaf Design” (“Timber Wolf/Maple Leaf Silver Round”), without the word “COPY” inscribed thereon, that was manufactured, imported, or sold by Defendants between March 7, 2008 and March 9, 2015 (the “Class Period”). To be eligible for relief, you must provide proof that the American Eagle Silver Round or Timber Wolf/Maple Leaf Silver Round that you purchased was manufactured, imported, and/or sold to you by one of the Defendants during the Class Period. In addition, you must return, by United States Regular Mail, the American Eagle Silver Round or Timber Wolf/Maple Leaf Silver Round that you purchased to the address set forth below before the Claim deadline, which is no later than June 10, 2015.

RELIEF SELECTION:

Defendants agree that each class member who submits a timely Claim, with the appropriate proof, will have the right to return each American Eagle Silver Round and/or Timber Wolf/Maple Leaf Silver Round they purchased without the word "COPY" inscribed thereon, that was manufactured, imported, or sold by Defendants during the Class Period and to receive, at the Class Member's option, either: (a) a new American Eagle Silver Round and/or Timber Wolf/Maple Leaf Silver Round, which is stamped with the word "COPY" thereon; or (b) a monetary refund of the American Eagle Silver Round and/or Timber Wolf/Maple Leaf Silver Round that they purchased at a price equal to the closing "spot" price of the silver contained in the Class Member's Round as of the date that it is received by the third party administrator. All shipping and handling costs associated with exchanging the American Eagle Silver Round and/or Timber Wolf/Maple Leaf Silver Round shall be paid by Defendants.
