Golden State Mint, Inc. agrees that each class member who submits a timely Claim, with the appropriate proof, will have the right to return each GSM Walking Liberty Design silver round(s) they purchased without the word "COPY" inscribed thereon, that was manufactured, imported, or sold by Golden State Mint, Inc. during the Class Period and to receive, a monetary refund of the GSM Walking Liberty Design silver round(s) that they purchased at a price equal to the closing "spot" price of the silver contained in the Class Member's silver round as of the date that it is received by Golden State Mint, Inc. Golden State Mint, Inc. will pay for uninsured first class postage on both inbound and outbound shipping and handling associated with exchanging the GSM Walking Liberty Design silver round(s).
